\$5.5 Million Being Returned to **Members in 2018 Capital Credits Paymen**

Thousands of Midwest Energy members are getting a pleasant surprise this month, as nearly \$5.5 million in capital credits from 1995, 1996 and 1997 are being returned to members in the form of a check or bill credit.

"Capital credits are the monies left over after all our expenses are paid," said Tom Meis, Midwest Energy's Chief Financial Officer. "In the corporate world, these would be called profits; but as we're a cooperative, we retain that money to reinvest in our business, then return it back to our customers on a roughly 20-year cycle."

Since Midwest Energy has no shareholders, we can refund money to you as new margins are earned. Capital credits are just one of the benefits of being served by a customer-owned utility.

Credits being returned, if any, will appear as bill credits here. Your Capital Credits Statement appears here.

Members who earned capital credits decades ago but are still customers of Midwest Energy receive their credits in the form of a bill credit. Those receiving bill credits will see them on their July or August 2018 bills. Members who have moved out of Midwest Energy's service area will receive a check. This is why it's important to update your address with Midwest Energy, even long after you move away.

In 2017, more than 6,000 members received bill credits. and a total of 15,508 former members were mailed

checks. The average capital credit returned was around \$195.

This year marks the 36th year Midwest Energy has returned capital credits to members. Over the years, nearly \$59 million has been refunded. (Continued on back)
